Board Members returning

This year, we have four members whose terms are up for renewal. Sean Halley and Thomas Dunahoe have decided not to return to the board, and Jim Hatton and Josie Jackson have chosen to return for another two-year term. Sean and Thomas will remain on the board until the 2025 AGM.

The Nomination Committee will be looking for 3 new members for 2025. Sean H and Joe B will head up that committee.

New Treasurer

Our current Treasurer, Bob Jones, will assume the role of President at the AGM in 2025. This means we need a Treasurer. We asked the current board if there was anyone interested in taking on that position, and there was none. Since we will be recruiting 3 new board members, we will do our best to see if we can find someone with a financial background, however, this is not a requirement. Bob has offered to stay as the Treasurer and the President next year if we do not find anyone. The group discussed this, and no one felt there were any issues if this were to happen.

Association Fee Increase for 2025

Over the course of the year, we have discussed that we were starting to feel the impact of cost increases at the clubhouse with utilities, supplies, and food. We have decided to increase the member association fees from \$15.00 to \$25.00 beginning in 2025. This should inject an additional \$4000 in revenue into the club to support our facilities and our activities.

Motion to be made to increase the fee from \$15.00 to \$25.00 Motion By Sean H and Seconded by Ken B . Motion carried by all in attendance.

Bob Jones has arranged a "Director Fun Day" on Saturday Sept 26 at 10:00 AM. There are 3 tee times reserved (12 spots). This will be for a Director and a guest. Closing of the clubhouse for the Winter

At the end of the season, we take steps to prepare the clubhouse for the winter. We have decided to ask Jack Panting to come and do the water work. The Internet and Clover Machine are cancelled. We discussed possibly leaving a small amount of heat on for the winter.

Also, it would be nice to get an energy audit completed before winter to expedite the installation of a heat pump. We want to do all of this ASAP.

Josie J has made a motion to authorize the executive to pay for the Heat Pump Installation with existing funds in the bank, however, if we do not have the funds to cover the cost, we are authorized to use funds out of the Building fund / GIC. Seconded by Kathy Steen. Motion carried by all.

New Business

Clubhouse Employee for the 2025 season - The Canada Summer Jobs initiatives could get us funds to hire a student for the role. We should form a committee to see if this is a viable solution. Patty (Chair) and Bob C. and Thomas have volunteered to form a committee on what is involved in this.

The next board meeting will be on April 17, 2025

With no further business, Ken B moved for adjournment at the chair's call. The meeting was adjourned at 7:55 PM.
